## ORDINANCE 4-09



AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE LAKE SHASTINA COMMUNITY SERVICES DISTRICT AMENDING ORDINANCE NO. 1-03 TO REVISE SEC 20.056 REGARDING DISHONORED CHECKS CHARGE AND EXHIBIT A THERETO.

The Board of Directors of the Lake Shastina Community Services District finds that Ordinance 1-03 sec 20.056 Dishonored Checks states: "At any time that the District or its designated agent receives a check dishonored by the bank for any reason, a charge contained in Exhibit A shall be imposed. The Board may immediately proceed with the collection process if the charges are not paid within ten (10) days after notice of the dishonored check is sent to the Owner." Exhibit A thereto states: "Dishonored Check Fee is \$2.50".

The Board of Directors of the Lake Shastina Community Services District finds that a fee for non sufficient funds (NSF) checks is allowed and set by Civil Code sec. 1719.

THE BOARD OF DIRECTORS OF THE LAKE SHASTINA COMMUNITY SERVICES DISTRICT DOES ORDAIN AS FOLLOWS:

Ordinance 1-03 sec 20.056 is revised to read as follows:

At any time that the District or its designated agent receives a check dishonored by the bank for any reason, the maximum charges and penalties set forth in Civil Code sec 1719 shall be imposed and the fee for non sufficient funds (NSF) checks, in any event shall not exceed the maximum charge allowed under any applicable law or District ordinance, whichever is lower. The Board may immediately proceed with the collection process if the charges allowed by law are not paid within thirty (30) days after demand that the dishonored check be paid is sent to its maker.

Exhibit A to said section is revised to read as follows: per Civil Code section 1719 maximum.

This Ordinance shall become effective 30 days after its adoption and shall, within 15 days after adoption, be posted on the District Bulletin Boards and published one (1) time in the newspaper for public notification.

9. Public Hearing: Delinquent Charges [Government Code §61115(b)] to be sent to 2009 Tax Roll: Public Hearing to hear and consider all objections or protests to CSD's Impending Delinquency Report of taxes, assessment and other charges levied for the fiscal year 2008-2009, being delinquent, shall be declared tax-defaulted pursuant to Government Code §61115(b) and shall direct the General Manager to file with the Siskiyou County Auditor/Tax Collector a copy of the final report, on or before August 10, 2009.

- 10. Siskiyou County Septage Treatment Project update: Dir. Wetter reported that at the County Board of Supervisors' meeting on July 14, 2009, it was reported that due to the present economy and the costs that would be incurred to build a septage treatment facility within the County, approximately \$700,000, the County is now considering hauling waste out of the County. Hauling to Anderson, California would cost \$0.12 per gallon and Merlin, Oregon would cost \$0.26 per gallon. With this option the County is estimating an expenditure of \$150,000 for haulers.
- 11. Signage for notification of Community events and urgent matters: Corinne Moller gave a presentation of two types of professional signage for displaying messages and events. The cost of the products ranged from \$6,000 to \$30,000. The Board thanked Corinne for her efforts and time researching this item and stated that they would contact her if the Board decided to consider proceeding with this item.
