**Judging:** 11/2/2022

**Winners Announced:** 11/9/2022 at POA Board Meeting.



#### **Winter Holiday Decorating Contest:**

**Nomination Period:** 12/1/2022 through 12/22/2022

**Judging:** 12/22/2022

**Winners Announced:** 1/11/2023 at POA Board Meeting.

### **Holiday Decorating Contest RULES & INSTRUCTIONS**

1. Participation is open to all Lake Shastina Property Owners.
2. Entry is free.
3. Entry is made by either signing yourself up or by nominating someone else through email at [lspoacmpl@lakeshastina.com](mailto:lspoacmpl@lakeshastina.com).
4. Board Members, ECC Members, Employees and family of LSPOA or LSCSD are not eligible to participate.
5. Entry Applications must be received **no later than 4pm** on the day before judging.
6. Contest is for exterior decorations only, Judging will be done from outside the residence only.
7. Judging will be based on "curb appeal" as viewed from the street only. Therefore, only those decorations located on the street sides of the property will be judged (corner lots will be judged from both streets)( decorations in backyard will be judged if they are visible from the street) . Judges will not enter the property to view back or side yards.
8. Participants agree to have one or more photos of their decorated residence exterior posted on the LSPOA Website and/or published in the LSPOA newsletter. Participant agrees there will be no compensation of any kind for said posting or publication.
9. Judging criteria will include [a] Unique design and creative use of lights and decorations; [b] Storyline or theme; [c] Display and placement of decorations, animated objects, etc.; and [d] Overall presentation.
10. Judging will be done from 6:00 p.m. to 8:00 p.m. on judging days. Depending on the number of entries.
11. Compliance Officer will judge the tie breaker for the winner this year.

12. Participants should ensure that all lights, animations and decorations are in place and activated for the judging periods on both nights.
13. Winners will be announced on 11/9/2022 and 1/11/2023 POA Board meetings. Winners need not be present to win and if not present will be notified by telephone or email.
